RULES OF CONSIGNMENT TO THE 2023 MINNESOTA GO-PHER THE PURPLE SALE



- 1) Consignors must be member(s) of the Minnesota Hereford Breeders. Membership must be paid and accounts current upon entry.
- 2) Paper entry forms will not be accepted. Submit one form per lot. **2023 MHB Go-Pher Sale Entry Form**
- 3) \$200 entry fee per lot. No refunds or exceptions. Made payable to the Minnesota Go-Pher the Purple Sale.
- 4) Cattle will sell under the <u>terms of sale suggested by the American Hereford Association</u>. Terms are cash or check with settlement to be made with the Sale Manager at time of sale. Absentee buyers will be invoiced following the sale.
- *To expedite the clearing process, consignors of 'No Sale' lots will be required to pay 20% of the sale price at settlement. Money will be refunded less sale expense after all bills have been collected following the event. The buyer assumes all risk on animals and genetic lots as soon as they are declared sold.
- 5) Original registration papers will be collected at check-in. As in the past, we will take care of transferring registrations following the sale.
- 6) All cattle must have a health certificate. Each animal must be individually identified to be ready for interstate travel. They will be collected along with registration papers at check-in.
 - Bulls over 15 months of age must be semen tested with papers.
 - All bred cattle must be pregnancy checked and noted on their health certificate.
 - All open heifers must be checked open and breed-able and noted on the health certificate.
- 7) Large wood chips will be provided in the barn. Outside bedding is not allowed. Cattle are welcome to tie-out in trailers or remain in the barn overnight.
